A 12-Point Plan to Prevent a Free People's Suicide

The following 12-point plan is prescribed by pro-life strategist, Rev. Jim Harden, CEO of CompassCare, paving the way for rehumanizing society. Making America great again requires making America moral again. This plan is submitted to several congressional leaders on November 6th, 2024, and should be considered by the incoming Congress and Presidential Administration.

Summary of Current Situation

Whereas President Abraham Lincoln observed, "As a nation of free men, we will live forever or die by suicide."

Whereas the massive Baby Boomer voting block sails to their sunset, their <u>average age</u> being 70 and the average <u>life</u> <u>expectancy</u> 77. That means by the time the next election rolls around many Boomers will have passed the mantle of influence to their left-leaning and larger Millennial progeny.

Whereas the current generational voting trends indicate this may be America's last chance to create the conditions to step back from the cliff of societal suicide.

Whereas the government, though downstream from culture and unable to effect moral change to re-humanize society, can remove some of the obstacles, rewarding evil and punishing good, to make straight the way for a return of righteousness—which includes punishing wickedness.

The following 12-point plan is submitted to optimize efforts to secure a bright and prosperous future for the United States of America and her people.

Summary of Current Situation 12-Point Plan to

- 1. Create a Personhood Act/Amendment, Constitutionally respecting the life of all humans from fertilization to natural death.
- 2. Ban all use of medical technology to kill or hasten the demise of any human, including euthanasia and physician-assisted suicide, complete with reinforcing the pre-existing duty to care for all medical professionals.
- **3.** Unmuzzle America's moral voice in the Church by repealing the Johnson Amendment that unconstitutionally forbids free speech from the pulpit.
- 4. **Repeal the FACE Act** which unconstitutionally restricts pro-life free speech. This will open the door for civil and criminal litigation against those who prosecuted pro-life Christians unjustly in violation of the 5th Amendment and Establishment Clause. Request Executive Pardons for all Pro-lifers imprisoned on FACE violations.
- 5. Sequester Funds that:
 - a) Aid abortion businesses like Planned Parenthood and abortion sanctuary states, conspiring to violate federal law such as what was done in <u>New York</u> and <u>California</u>.
 - b) Aid politicized federal law enforcement within the DOJ, FBI, DHS, and the DoD until a thorough investigation can be completed into both the nature and extent of the abuse of power leveraged against pro-life Christians as well as the constitutionality of federal law enforcement per violations of the 10th Amendment.
 - c) Aid any government agency that uses DEI as a hiring policy, including the DoD.
- 6. Purge the State Department of Abortion Ideology and Policy, which holds aid to 3rd World Countries hostage to evil population control ideology. Then apologize to those countries on behalf of America.
- 7. Combat the sex-crime industry, exposing the abortion industry sex-crime cover-ups, assisting in funding State Attorneys General to audit the abortion industry comparing abortions given to minors with the lack of reporting of sexual abuse.
- 8. Appoint a new U.S. Attorney General, demanding he or she enforce the Comstock (forbidding the interstate shipments of the abortion pill) and Mann Acts.
- 9. Advocate a new Nuremberg-esque Trial for crimes against humanity committed in the name of medical care through abortion, transgender therapies, and surgery, as well as vaccine mandates and injury in violation of informed consent and appropriate animal and human subjects testing before use. This alone could spark a moral revival.
- 10. Place a Moratorium on *In Vitro* Fertilization (IVF) until Rigorous Regulations and Frozen Embryo Adoption Plans can be implemented including bans on embryo culling, multiple embryo implantation, and indefinite embryo freezing without predetermined adoption placement plans, while seeking to find 'willing wombs' for the tiniest of human beings currently living in cryogenic suspension.
- 11. Activate Project S.T.O.P. a 7-Point plan to abate the epidemic sex abuse and slavery of women and girls.

This includes actions like a) reinstatement of rapid DNA testing for minors and families at the southern border, b) demanding all state Attorneys General engage in civil investigations into unreported abortions perpetrated upon minors, c) mandating all abortionists report all abortions committed against girls under 18, transported across state lines in violation of the Mann Act, or to whom drugs were shipped across state lines in violation of the Comstock Act, d) mandating all purveyors of sex trade gateway drugs like porn must be registered with every state similar to telemarketing solicitors.

12. Implement the <u>9-Point Plan</u> to Protect Women and Children from Abortion Fraud and Injury.

This includes steps like a) repealing the unconstitutional FACE Act, b) investigating government actors to Indict for Violations of USC 1983 for conspiracy to deprive pro-life Christians of their 1st, 5th, and 14th Amendment rights, c) pressure states and nations to stop the illicit sale and shipment of abortion drugs into the U.S. and across state borders, and d) explore Big Corporation's Violation of the Pregnancy Discrimination Act.
